

CAMP AVERY USAGE GUIDELINES 2025

1. **USE OF CAMP AVERY:** and all included amenities are at **your own risk**. Camp Avery is not responsible for damages to personal property while using camp premises.
2. **TWO DEEP LEADERSHIP:** Minimum of two registered adult leaders must be present for the duration of the event when youth are present. Two deep leadership must be maintained at all times.
3. **CAMP USE REQUESTS:** Requests may be made in person, by phone, or email. Camp use is on a first-come, first-served basis and will be dependent on the needs of participating units of Camp Avery. The adult in charge must complete and sign the Camp Use Request Form and present it to the Camp Avery Committee for approval.
4. **PARKING:** All vehicles must park in designated parking areas. Driving through parade field and on sites is not permitted without prior permission.
5. **SPEED LIMIT:** The maximum speed limit on camp property is 5 mph.
6. **LIGHTS & STOVES:** Liquid fuel lights and stoves may only be used under adult supervision and must abide by regulations set forth by the Guide to Safe Scouting . A 12" minimum clearance from trees and overhanging branches is required.
7. **GARBAGE DISPOSAL:** All waste materials must be disposed of properly. Trash must be removed from camp property upon completion of the event. Trash may not be left out overnight.
8. **FIRES:** Build all campfires in established camp fire pits. Use proper approved fire procedures as defined in the Scout Handbook. All fires must be out cold before leaving the camping area. All campfires must abide by regulations set forth by the regulations set forth in the Guide to Safe Scouting and follow principles of Leave No Trace.
9. **FIREWOOD:** Do not bring in outside firewood! Please use firewood only from established piles on the property or previously fallen timber. Absolutely no cutting

down trees.

10. **LATRINES:** are available on site, please bring your own supplies (toilet paper, soap, paper towels). Please ensure latrines are cleaned prior to departure.
11. **POTABLE WATER:** is available via three ground hydrants on site. Please ensure these valves are CLOSED when not in use.
12. **PROHIBITED ITEMS:** Alcoholic beverages, illegal drugs, ATV's, fireworks and firearms are not permitted on camp property. Offenders will be subject to immediate dismissal from camp property.
13. **ACCIDENTS:** All accidents and emergencies should be reported immediately to the Camp Avery Committee Representative.
14. **PROPERTY OR EQUIPMENT DAMAGE:** The Unit assumes a liability for abusive damages to camp facilities or equipment. Locked areas of camp (gates or buildings) are off-limits without prior approval from the Camp Avery Committee.
15. **USE OF CAMP BUILDINGS:** Camp Buildings, aside from latrines, are off limits unless prior permission has been obtained from the Camp Avery Committee.

I have read, understand, and will follow the aforementioned regulations. Failure to adhere to these regulations may result in my unit forfeiting their privilege to camp at Camp Avery in the future.
